Each year, Chairpersons/Judges will assess and score student presentations at conferences based on the innovative ideas, communication and interaction skills.

Women Scientist

The concept of award will motivate the women researchers and anesthesiologists to achieve more which will in turn work towards the betterment of conference. The evaluation of presentation will be based upon the Pharmaceutical Care, Pharmacy, Pharmacology and Toxicology.
