

## Implications of Case Reports in Medical Development

### Global Market Share

The manufacturers in Europe control the majority of the domestic medical device industry, but the currently market is relying on the import from the markets across the world. Medical device imports accounted for about \$3.8 billion in 2015, more than 50% of the overall market. The medical device packaging market in Europe is expected to grow at a CAGR of more than 7% by 2018-2022. There were approximately 1.8 million physicians working in the Europe. The overall number of physicians which are practicing in Europe were recorded in the largest Europe Member States were: Germany (3, 33,000), followed by Italy (2, 36,000), France (2, 06,000), the United Kingdom (1, 81,000) and Spain (1, 77, 000). These five States all together accounts’ for about two thirds, which is about 64% of the total number of the physicians practicing in the Europe, above their combined 63% share of the EU’s population.

### Market Report:

The French demand for pharmaceutical and medical products is the second largest market in Europe and the 5 th largest market in the world. The French market was estimated at US \$14.5 billion in 2014 and growth is expected to be modest, hitting US \$16.5 billion by 2019.

people working in Clinical Research Organizations, and Students studying Life Sciences. There are currently about 2, 00,800 physicians licensed to practice in France. In the last 30 years the increase in the number of physicians had tripled, but the rate of increase is now very slight. But, till since 1971, the Ministry of Health has limited the number of medical students, a measure which, along with the retirement of currently active doctors, will result in a decrease in the number of physicians in the near future.



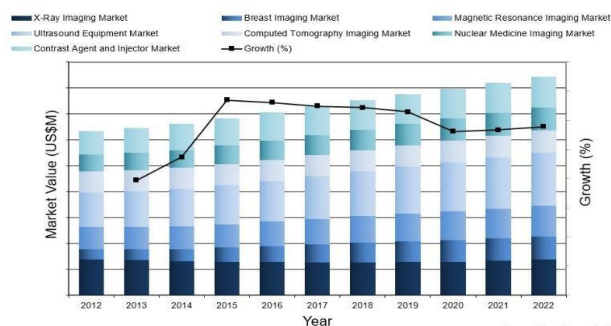
### Global Business Value:

The growth of the market is attributed to the increasing adoption of digital pathology to boost research laboratory potency, rising prevalence of cancer, growing applications of digital pathology in drug development and companion medicine, easy consultation and increasing initiatives by governments and business players. Introduction of reasonable scanners for pathology practices, personalized drugs and integration of laboratory info systems (LIS) and digital pathology systems are predictable to supply important development opportunities for makers in the coming years.

The marketplace for anatomic pathology worldwide can doubtless rise at a gentle pace of 6.5% during the period from 2017 to 2025, predicts a report by Transparency Market Research. At this pace, the market is projected to clock a price of US \$30,314.5 mn by 2025- end from US \$17,318.0 mn in 2016.

Depending upon product and services, the global market for medical pathology can be segmented into consumables, instruments and services. The segment of instruments can be divided further into tissue processor, microtomes, slide strainer etc. The services phase, among them, leads the market at present on account of the rising instances of critical illnesses needing urgent medical attention. In 2016, it accounted for a major 45.9% share in the market.
