

# The Robberies and the Embezzlements Made to my Journal, The Cellular and Molecular Biology®

#### **Summary**

It is the story of the manner with which the most dishonest publishing company of the world, Elsevier, with the help of an abominable traitor issued from my editorial board, named M.A.Q. Siddiqui, from the New York City University, as well another disgusting traitor, this time issued from the university of Poitiers, Jean-Michel Maixent have both groups stolen my journal with the most ashaming underworld tricks. I explain how they have proceeded in the perspective of exactly the same objectives: to become the owners of the terms "Cellular and Molecular Biology®"whose principles have revolutioned the biology and to earn a great amount of money from its world reputation and its uses.

The affair launched in 1990 against me from Elsevier ended lamentably for this company which after having issued in 1993 a journal of exactly the same terms as my journal, but by adding behind CMB the term "Research" (Figure 1) had provoked great trouble with the librarians and all subscribers suddenly confronted with two journals of the same terms. I explain how the little David I am, I have destroyed the giant Goliath Elsevier.

Now my fight continues against Maixent, who has cheated me in an incredible manner in 2006, whereas I am still waiting for an end judgment, having been able, thanks to a young indo-american publishing company named OMICS to overcome the blockade made by Maixent and by the President of the Court of Poitiers, a female judge called Lacoste who has helped the criminal Maixent to block my web site until to-day. Maixent will finish tragically his life as well as all those implicated in the robbery of my journal.



#### Introduction

This paper is the first of a new series after an interruption of exactly six years and all what has been presented in my journal during this lapse of time has been made totally illegally by the worst hoodlum existing under the heaven, an individual named Jean-Michel Maixent, a former professor of the Faculty of Sciences of the University of Poitiers, France heavily condemned and ousted from the university in may 2012 like a miserable lousy dog.

The stories of both robberies are truly those of a black romance in science and are the worst which had happened in the Annals of the Sciences in one century, because having happened now twice in less than 25 years. The proof is given that a publishing company like Elsevier and scientists may be criminals of the worst sort, having become in modern time like Maixent even a typical cybercriminalist.

The first affair, with Elsevier, began in the following way. After having created and published in the year 1950 my first journal, the "Annales d'Histochimie\*" (Figure 1), just after having become assistant professor in medicine at the young age of 26 years and having become an histoenzymologist and physicist, having created at the University Descartes of Paris a splendid research Institute called "Institut d'Histochimie Médicale", I developed progressively a new science in biology, integrating biochemistry, biophysics, mathematics, immunology, histochemistry, enzymology and other more, building up a true and totally original, new interdisciplinary science which has

been applied already from 1950 on and what has attracted over 350 scientists from the entire world in a lapse of 40 years. But as it has been demonstrated later on it was my new science which has been at the basis and applied by many important scientists, who received their PRIZE thanks to the application of my new principles, so that many of these Laureates belong now to my Editorial Board, having stated it clearly in their conferences at the occasion of my CMB World Congresses.

# The Story of the First Robbery of the Cellular and Molecular Biology\*


I became in 1970 chairman in Histology at the Faculty of Medicine of the French University of Lebanon at Beirut but taught exclusively

cellular and molecular biology so that it became the first chair in the world wearing this title, having joined to it a splendid research laboratory equipped with the most modern instruments, including a computer; at a moment where did exist neither Apple nor Windows but having linked all my new instruments with this computer so that it was also the first totally automated laboratory functioning in an university Soon the Faculty of Medicine of the American University collaborated with me as well as the Lebanese University and rapidly the fame of this collaboration extended in all countries and in this time I have been named Dean of the School of Medicine of the Rutgers University.

In this time I received as well the visit of a british gentleman named Bob Maxwell, the founder of Pergamon, living at Oxford in the splendid Headington Hill Hall and he convinced me to publish my journal in his company, what I accepted by changing the name of my first journal in "Cellular and Molecular Biology\*". My activity and my researches, particularly with the American colleagues became important and highly interesting, because the biopsies I could perform at the french University permitted to discover an abnormal number of cancer of the bladder and the American faculty had permitted me to obtain a total new insight in the metabolism of the female fecundity and sterility, thanks to the fact that all biopsies were cut in a cryotome and studied with enzyme reactions and immunological activities.

This lasted about ten year but by pity the lebanese civil war interrupted this marvelous activity and I returned to Paris, after having been nearby killed by the feddayins but saved by the ambassador of France's chauffeur who was a chief feddayin and who protected our ambassador. The drama was that the charming ambassador delamarre has been killed three months after my departure by the same feddayins but after that his chauffeur had died by an infarct a so that the ambassador had no more a protector. At Paris I continued to lead my institute having created at then same time in 1980 a private informatics center for Holter-ECG, Holter-BP and Holter-EEG, called CADMOS® ( Computer Analysis and Diagnostics by Monitoring Systems) having as well built a totally new, purely electronic Holter-BP monitor, making all others totally outdated, because they are all only pneumatic, called as well oscillometric. This monitor will presumably be manufactured by OMICS, at Hyderabad and applied to a general survey of the 140 million hypertensive subjects of India, thanks to the patronage of the IMA (Indian Medical Association) whose numerous medical practitioners will use my new monitor in their daily practice, so that this study does not need any costly program of any sort from any learned national or international society.

I learned in 1990 the tragic and mysterious death of Bob Maxwell and that Pergamon had been sold to Elsevier. It was at that time that a member of my editorial Board, named M.A.Q. Siddiqui, an american

of Pakistani origin, to whom I wanted to transmit the function of an Editor-in-Chief but not knowing that I was the owner of my journal, took secretly contact with Elsevier, proposing to it in his unlimited ambitiousness to become the Editor-in-Chief, what pleased Elsevier which had pretended at that moment that the CMB belongs to Elsevier as the follower and of a legacy of Pergamon. But I refused to accept the ukase of Elsevier, the problem was that, when I began to collaborate with Pergamon, I had several times claimed from Bob Maxwell to receive an official contract and Bob answered each time that our so friendly relations did not need a contract and that our collaboration was based on a "gentleman agreement". I told that to Elsevier insisting on the fact that me I am the founder and the owner of my own journal. But Elsevier did not accept my protests and intended me a terrible lawsuit, launching against me his sixty two lawyers, whereas me, being as well an international lawyer, I had only the help of two French friends, both professors in law, who lived at the same moment like me in Lebanon, so that we were only three to defend my position. The battle was terrible because they rummaged all enacting terms in the most incredible manner, having gone back to the Middle Age to obtain my condemnation.

# The Killing of the Pirate "Cellular and Molecular Biology Research"

At the same time, Elsevier, on the demand of the abominable traitor Siddiqui began to publish a journal exactly of the same type like my journal, having had he cheek to include in his pirate journal all my friends and fellows of my Editorial Board. But they shot back with firy bullets and the traitor had to find a lot of totally unknown and incompetent people to fill up his new editorial board but who have accepted only if they are paid, what represented a terrible heavy financial load for the pirate journal, as so more Siddiqui had requested a fortune to be the Editor-in-Chief.

My chance was that previously I had requested that absolutely all papers had to be to sent to me and not to Pergamon. So it happened that in spite of the enormous propaganda made by Elsevier, the papers continued to reach me alone and none the pirate journal. In such a bad perspective for his pirate journal, Siddiqui requested a paper from each of the numerous editorial board members. But none of them was a cellular and molecular biologist. The result was catastrophic, the papers were all what you wanted but not any from my domain. They were a mixture of anything with anything, a mixture of puddlemuddle, physiological papers with purely biochemical papers if not with analytical chemistry or theoretical physics with no any relation with biology. It was simply horrible. But also the presentation of the papers was a marvel of disorder, because you could find, printed in the middle of the page, the text of the topic of the paper which normally you find at the upper part of the page. And the number of faults of the English language was simply stupefying. None of the papers had been submitted to Peer Reviewing. It was evident that with such a situation the pirate journal did not have any chance to progress nor to survive. And that made me thinking how to give a heavy stroke to this damned Siddiqui so that's will be an end with his pirate journal. The occasion was soon given to me.

When came the period of renewal of the subscriptions, the librarians, at 100% refused to subscribe to two journals having the same title and consequently neither Elsevier nor me had the slightest subscriber. It was dramatic for me, me supposing that Elsevier had enough financial reserves to overcome the difficulties. But I learned from somebody inside of Elsevier, having belonged formerly to Pergamon and who had remained faithful to me, the true situation and he has sent me all

proofs which I still possess. With these documents in hand, I decided to hit down Elsevier, to give it a deadly blow. Consequently I went several times to USA which I knew like my pocket having been there a Dean, and visited the greatest amount possible of librarians explaining them the behavior of the traitor and of Elsevier and requesting them kindly to transmit my message to all other librarians. I had full success, namely that they refused absolutely all to subscribe the pirate journal and subscribed only my journal. That has killed the pirate journal because my informer learned me that Elsevier has become terribly furious against Siddiqui about his financial catastroph, no any cent income and millions of dollars expenses, for nothing. Siddiqui has been ousted like a lousy dog and the pirate journal disappeared after only two years of existence! But during this time the French justice, the most stupid of the world, had accepted the arguments from the hidden store of the zealous Elsevier lawyers which were based even on Middle Age decisions condemning women to be burnt under the pretext that they were witches. I have therefore considered from Elsevier that I am a wizard. But Elsevier did not measure enough how dangerous was and remains this wizard until to day for it.

But I have not been condemned to be burnt but it would have happened if we were still in the Middle Age, Elsevier would have willingly brought me on the stake to be burnt. But it never had the courage to claim to obtain the damages it had requested, one hundred thousand francs, a fortune for my poor salary! Once more I learned from my faithful informer that Elsevier had received a terrible threat from "somebody" of the group of the Nobel Prize Winners - I know who was this Nobel Prize Winner! - speaking in the name of all others, saying that if Elsevier tries to request even one cent of the sum of condemnation they will all launch a terrible attack against Elsevier so that they will reveal what kind of pirates and gangsters is this from all American librarians detested company so that this company will regret this attack in all eternity. I was immensely happy to learn that Elsevier has been killed as well thanks to my Laureates and has been totally and definitively reduced to silence. And I have never learnt what has happened later on to the dirty hoodlum Siddiqui. I know that a claim has been made against him in his university but this evil not glorious individual, so terribly defeated from me, seems still to exist but reduced as well to silence.

#### The Second Robbery of my Journal

But I had been too happy too early because the same story has happened to me 23 years later with another horrible miscreant, Maixent. In the year 2004 I had observed that my luxurious and prestigious journal, the Cellular and Molecular Biology®, founded in the year 1976 by changing the title of my previous journal, the "Annales d'Histochimie®" which had been founded in the year 1950, had become no more worthwile, the costs of managing, printing the 1400 pages a year and sending per post having exceeded largely the nevertheless comfortable income. I decided to publish the journal on line and I found through a former fellow, chamlian from Marseille and whom I accuse to be greatly responsible to have my difficulties, because if he would have been more perspicacious he would not have recommended him to me.

Maixent was employed as a researcher in some pharmaceutical industry when he has suddenly been favoured by an old professor of Poitiers, whom I have met during a meal, and who knew perfectly well the peculiar, not brilliant origins of Maixent, which you will learn a little bit later in this paper. Maixent has been named on the spot, without passing the regular steps to become a professor of physiology using exclusively informatics. When I came in contact with him he

accepted immediately my proposal to take in charge the publication on line of my journal. And me not wanting that he had to do that job without being paid, I proposed as well to him first to lead the 4th World Congress of CMB at Poitiers, because a congress permits always to obtain some substantial revenue. I invited twelve Nobel Prize Winners but nearby a terrible scandal would have happened because Maixent had pretended that a politician named fouché had said that he has to provide whores to the Nobel Prize Winners coming to the congress without their wife "in order that they are not too much lonely".

I discovered later on, after the congress, that it was an immense lie from Maixent. If the congress was a success, I wanted nevertheless, after the congress, no more that Maixent takes in charge my journal because an incident had happened which has troubled me greatly. On the last day of the congress, it has been decided that Maixent should bring me at the train station. But he was so terribly drunk that he drove his car like a foolish man, running mostly reversely in one way streets so that I feared greatly an accident. And during this time he claimed loudly:" I was a baby found enveloped in rags and tatters in a rut of the low quarters of Poitiers. But to-day I have my revenge ". And by saying that I discovered suddenly, in my bewildertment, a guy who was searching to forget his miserable origin and who was, according me, able of any kind of revenge. But I did at that moment not go farther in my thinking, because the near future demonstrated to me that he was able of the worst sort of revenge by becoming a robber and an embezzler of the worst sort and not only of my goods alone, but as well a true criminal! And finally, instead to bring me at the entrance of the station, he brought me on the back side, so that I had to cross with my luggage dangerous numerous rails to reach my train, at the last minute! A trip of a foolish man from a psychiatric institute!

### The Falsification of my Charters by Maixent

Therefore I searched for somebody else during nine months after the congress and I did not find anybody. That obliged me to take him as the only online editor available. But warned about the affair of Siddiqui and about the defiance towards Maixent, I decided to write very severe charters in order to protect my property, the journal. According the french laws I had to create an "Association of Cellular and Molecular Biology". A student of Maixent came to my home and I gave to this student a copy of my Charters signed by me, having asked Maixent to sign the other copy as well. After a few days the student phones to my wife saying that Maixent cannot deposit the charters on the Prefecture without an official letter from me saying that it is me who has written the charters and I have sent the letter. But Maixent learned me that he has deposited the letter and the charters only one month later; having pretexted to be overbusy with his students. That was a double lie because never the Prefecture has requested such a letter and moreover he had used one month to write his own charters with the help of a lawyer, having finally deposited the false charters which became the official charters, because my charters have never been registered.

In these false charters he had named himself as the owner of the journal and me being simply his secretary, having photocopied my signature from the extorted letter and signed with totally fantasist paragraphs. And it is with these totally false charters that he has made all the falsifications and all this disorder and opened four secret bank accounts in which he has deposited all his considerable financial robberies whose total amount is still unknown but seems to be very high. And me, believing that all was nevertheless OK, I decided that the collaboration began.

But after some months, already claims reached me mostly for no answer of Maixent or of very late answers. I wanted to accept these claims knowing that he was very busy with his teaching but when the number of claims increased I begun to become anxious. Consequently I went anonymous to Poitiers to look after the matter and I discovered that Maixent did absolutely not take care of the edition of the journal, but left to his student all problems to solve whereas none of these students knew anything from cellular and molecular biology and even less of the english language. I reproached severely to Maixent his laxism and he behave like a punished little boy, humbly asking for pardon in the most lamentable manner, explaining the situation because of an excess of work and promising that what happens is only transitory and that he will improve the activity so that I will never more make a claim. And me, in a first time, I believed all this balderdash, not knowing that his manner to behave so was simply a system to avoid more complications and reproaches, like do it all deeply hypocritical guys, when one day one my friends, Eugène, professor of medicine at the faculty of medicine of Poitiers and whom I knew since long years from Paris warned me against this individual saying me that I have to take care because he is known to be not very honest and even dangerous.

#### The Dissolution of the False Association CMB

From that day on the relations became tense with him and when the claims became too numerous I requested from Maixent that he gives his resignation. But I was astonished when he refused and has sent to me a letter in which he pretended to be responsible in front of the laws and that thanks to him the journal survives. I wanted to intend a trial against him when suddenly he gave the resignation of his activity as the "president" of the association and consequently as the "owner" of the journal. This resignation came one day after that my friend and fellow, professor Bara who had accepted to be the treasurer of the association had as well gone away. The consequence was that I remained alone at the head of this association so that I found me obliged to order Maixent to hold immediately another staff meeting in order to re-elect a new staff. But I was astonished that Maixent refused, so that immediately I intended against him a referee trial but the judge was so immensely stupid that he claimed loudly in the chamber: " I have never seen such a situation. I don't understand anything " and... relaxed Maixent. I intended another referee trial but this time the judge was even more stupid because he "classified" the trial under the pretext that nobody came to the chamber. And the explanation of this absence of the justiciables was simple: his assistant, a female had prevented me from sending the convocations to these grantees by refusing to make the photocopies of the convocation letters. That is French Justice. Lamentable!

## The Discovery of the False Charters

Months passed and I did not know what exactly to do when, in december 2010, my wife had a genial idea: to request from the Prefecture a copy of the charters deposited by Maixent in 2006. And in January 2011 they arrived to us: we were stupefied and scandalized. The charters were totally falsified, had only 6 pages instead my 16 pages. Maixent had therein given to himself all power, pretending to be the President of the association and the owner of the journal, having reduced me to a simple secretary of his association. The charters were signed with my signature, but not with my original one and simply photocopied from the famous letter he had extorted me having pretended that the prefecture had requested it, what was an enormous lie.

Having now in hand the proof of the unbelievable dishonest behavior of Maixent since march 2006, and particularly that the Association CMB mentioned in these charters was a totally false association CMB and not my true association CMB, I believed that now I come rapidly to

a issue. That was a great error from me to believe it, because I had soon to discover with a great pain the unbelievable juridical complications resulting from the tragical fact of the registration of these false charters at the Prefecture, because these false charters having been deposited by Maixent, they have consecutively be considered uniquely as the true charters, because my own and true charters had not been registered.

I did not know what to do. A lawyer from Paris whom I had requested to bring Maixent before court behave so lamentably that I sued this lawyer who has been condemned to pay back a part of the fees paid to him. Generally said I have not great respect towards the lawyers because I consider that they plead much more with and in favour of the articles of the laws than in favour of the facts themselves. They are the men of the words but not of the facts. In the Bible is written: "In the beginning was the word. I don't believe it, because nobody was there to listen the Word but rather that at the beginning was the fact of any kind, like, by example, the Big Bang or something like. That is the reason that my symbol is a spiral, even if the from the cosmologues and astronomers admitted spiral turns from right to left, my SPIRAL is turning from left to right, the beginning of all being represented as the tiny point of the center.

#### The Condemnation of Maixent

But soon happened a great event. In may 2012 I learned from my friend professor Eugène, that Maixent had been very severely condemned by his university, as professor Bara had announced it to me already in the year 2010, for an incredible number of embezzlements and robberies with a lot of falsifications of official documents at the disfavor of the university, having as well stolen the registration fees of his own students who came at the end of their 5 years studies without obtaining a diploma, because the accountant of the university had never received their fees, cashed by Maixent, what was the most abominable crime this abominable scoundrel and malefactor Maixent could commit. He has been demitted on 29th May 2012 of his title as professor, of all his functions in the university, like teaching, doing researches, the use of the telephone and the e-mails and even forbidden to put his dirty feet on the level of the campus of the university. In fact in one word, he has been ousted from the university like a lousy dog. The complete document of his ejection from the university can be seen in Wikipedia. Moreover the president of the university and the dean of of his faculty have intended to him each one a law suit which is under way.

But at the same time it was learnt that the C.I.D., the Criminal Investigation Department had as well launched a case against him because it had been discovered, what I knew since several years, that he has made innumerable expert appraisals in favour of the pharmaceutical industries, by using all his students, without paying them in anyway and by cashing enormous financial incomes without informing the accountant and the president of the university from whom he should have requested the permission to do these heavily paid studies, and to whom he should have paid 10% of his incomes for having used the commodities of the university.

It was learnt at that moment that he had hidden all these fabulous financial amounts in four secret bank accounts, the bank Barclays, the Postal bank, the bank Tarneaud and the bank Bred, but whose amounts remain until to-day not known as long a definitive judgment has not been obtained to oblige the bank to furnish all information. And how he could obtain the opening of these accounts? Simply because he had used his false charters presenting exclusively my signature photocopied from my letter. It is important to signal that the bank Bred which was my bank since 1990 used for the accounting of my journal refuses to me since 2010 to recuperate the sums I have deposited there, under

the pretext that they belong to Maixent, having received the charters from Maixent in which he declares himself as the owner of my journal. I have to make a trial against this bank to obtain its condemnation. But in France the Justice is the worst of the world and until now I did not obtain any result.

### The Tragical Illegal Behavior of a Female Judge

Only eight days after this very heavy condemnation of Maixent, a female judge, president of the High Court of Poitiers, named Lacoste, who was perfectly well informed about the ejection of this criminal individual from the university of Poitiers, has on behalf of a demand of this scoundrel emitted a judgment based on the article 490, according which she has decided to obtain the reorganization of the Association CMB created by Maixent, therefore the false association CMB, by making new elections.

The first curiosity was that Maixent had refused to make this election immediately after his resignation because I wanted to create again the association destroyed by himself. The second curiosity was that the female judge had considered that all members of the staff had resigned with exception of me what has decided her to rename me as the secretary of the false association without asking my advice and even less my permission, having simply decided that that me I am still the secretary of the association. The third curiosity was that Maixent, charged to recreate the false Association CMB, has presented as being members of his initial association in 2006, not less than fifty chinese authors and twenty five totally unknown people, whereas no any of all these names was mentioned in his first and false association. And that has nevertheless been accepted by this female judge as legal! A truly curious legality to which the neck has been twisted and strangled! The fourth curiosity was that this horrible female had linked the result of the election, that is the reestablisment of the false association, with the destinee of my goods, that is to decide to whom my goods have to be attributed. And that is the most fantastic part of this impossible story.

# The Referee Judgement

In January 2013, after having introduced in September 2012 a new writ in prosecution against Maixent, the female judge Lacoste agreed in her justice decision of a referee to condemn Maixent to give me back all my properties transmitted to him in order to exert the function of an assistant-editor on line of my journal. In this judgment she has several times recognized that absolutely all elements like the web site, the list of the subscribers, the bank accounts and all the numerous documents given to Maixent belonged really to me, that I am the founder and the owner of the journal, that the world reputation of my journal is due to me, that all the nuisances and obstacles made to me come from Maixent. She nevertheless decided, by repeating it three times the terms, to place all my goods under sequester! Such a decision was simply stupefacting, enormous, incredible! Why was such a decision immensely illegal, hitting frontally the Human Rights?

Simply by the fact that goods pertaining to somebody who is known to be the true owner of these goods and who has not committed any fault at and is not sued in any way by the justice cannot be placed under sequester! So by example, after the war 1939-1945, many goods have been placed under sequester of people in France having collaborated with the Nazis. But no any of the Resistants fighters against the Nazis have seen their goods submitted to a sequester And only a judgment could decide about the fate of the goods of the collaborators which were seized for the greatest parties. Consequently the decision of this damned woman, she may be a judge or not, I was totally and definitively illegal. I have decided that she has to pay heavily such a tragical and totally erroneous illegal decision.

I have written to her, and sent a copy of it to the Minister of Justice, that I make a trial against her for association, favouritism and protection with a criminal and that she is nothing else than a malefactor who is the accomplice of a gangster and who has helped a criminal to destroy the fruit of my life, namely my journal the Cellular and Molecular Biology\*, a scientific journal founded over sixty three years ago and who presented twenty two Nobel prize winners, the unique scientific journal of the world having been able to present such a famous areopage. I have requested that she has to be very severely condemned, to pay very high damages, as much as Maixent, to have to be ousted from her position and to be no more permitted, for life, to exert any juridical or administrative function.

#### The Actual Situation

This situation is actually totally crazy. In June 2013 I have laid, once more, without the aid of any lawyer, at the attention of the Dean of the judges of the High Court of Poitiers, a penal charge against Maixent, having presented all the elements as clearly like in this paper. But, beginning September, I have received an answer from this judge, a woman who has rejected my charge under the pretext that I have introduced it to late because its origin goes back to 2006. I was once more stupefied about such an incredible affirmation demonstrating the bad will of this judge, followed soon by the same rejection by the Prosecutor and the Attorney General who simply repeated the same balderdash and said to me that I am foreclosed.

I wrote immediately to all three parties demanding them ironically if they believed that I am nostradamus or a fortune teller who knows what will happen in the future or who knows how a crime has been committed seven years before it could be proven. I said that I am as well unable to read in the coffee grounds or in a cristal sphere and that the crime has been committed in the year 2006 but discovered only in the year 2011. And by saying that I have sent at the same time the letter received from the Prefecture in January 2011 together with the false charters. And since this time it is the silence which reigns. For me the situation is clear. They have taken a bad pretext in order to protect the female judge Lacoste, having with all evidence observed that she has really made a terribly false fault against the law so that that they don't know exactly what to do.

But there are also other fundamental reasons. In my charge against Maixent and Lacoste, I have charged as well the President of the University of Poitier, named Bessons and that for a very specific reason. During the six months between june 2010 and january 2011, my idea was to recuperate as rapidly as possible my web site in order that the interruption of the publications of the papers does not suffer too much. I have consequently tried to obtain the keys of my web site,that are the identifiants and the passwords, which are in fact in the hand of the president of the university, Maixent having learnt to me, and I had the proofs in hand, that my web site "cellmolbiol.com" was without doubt lodged inside of the university web site, that for facilitating the publications of the papers but also merely for making great economies, because the maintenance of a web site is rather expensive.

Having announced me three times and even once with an usher, and having each time obtained the agreement of a meeting with the president, he nevertheless has refused three times, for unknown reasons to receive me, but each time with a bad pretext, what made me severely mad. I accused him consequently to have voluntarily made obstruction to obtain the opening of my web site, and to have boycotted me what has led with all the other circumstances to the death of my journal and to the total loss of my prestigious reputation. I am still questioning me of the true reasons that the president has refused to receive me. I

suppose that he too, has initially protected Maixent against me, who is a foreigner of this university, so that I consider that he is as well, like Lacoste accomplice of the crimes committed by Maixent and consequently that he too has to pay heavily for this bad affair.

I am now under way, with a highly experimented specialist of penal charges, one of the rare lawyers in whom I have respect, to reestablish the way to obtain justice, what in France is worse than to try to win the great lot at a lottery. The next months will be crucial and I will later on publish the results.

#### Conclusion

This paper has demonstrated first at all the incredible attraction, a true pathologic fascination from a publishing company like Elsevier to try to corner by all means possible, even with the most dishonest, detestable and shameful one's a journal like my journal, knowing its universal importance not only because of its interdisciplinary orientation but being as well the unique scientific journal presenting 22 Nobel prize winners in its Editorial Board and that in order to increase its prestige and reputation, but which is very bad and terribly low in USA, this company behaving as the most money greedy from all other companies and the most voracious in terms of exaggerated amounts of the subscriptions! A company which has to be under control! And whose future is aleatory!

Moreover it shows the same pathological tendency from a shabbylooking individual ejected from his university, Maixent, who has never been able to produce anything important or valuable contribution in his life and who suddenly finds the occasion to try to become important by robbing with a true criminal system the achievement of the entire life of a professor whereas this individual is a definitively total and bumptious nullity, an individual of the lowest category, issued from the underworld and who represents an incredible danger for any person who may have confidence in him, having cheated me in the worst manner from the first hours of the contact with him, after having deposited totally false and fraudulent charters like a dramatic example has been given here. And from all that had resulted a lot of unbelievable disagreements of all sorts, as well juridical as financial.

But this papers shows as well the difficulty to find the convenient person to be charged with a special duty, like here as an associate editor, what is is a difficult task whereas there do not exist criteria permitting to measure the honesty of an individual, because the people may give easily the change even if a psychoanalysis is made. I don't believe that a Director of Human Relations like so much are actually issued from the very expensive Commerce Schools is able to detect the adequate candidate. The failure of Chamlian is a typical example that even a professor is unable to judge correctly the moral and ethic value of a candidate.

Nevertheless in the actual case, the criminal behavior as well of M.A.Q, Siddiqui who seems to be still living but not very gloriously nor happily at the New York University as of Maixent ousted from his university are two typical examples of habitual criminals, accustomed to be malefactors and true poachers, who are specific kinds of rascals, swindlers, making easily breach of trust, being gangsters, forgers, blackmailers, towards whom we have to seek redress, whose impostures and dismeamour are their daily habit, who have to be sentenced in the most heavy manner and who have to serve a long term, not forgetting to pay heavy damages at the level of their important thefts.
