Introduction

Written by Hng Hung Yong and translated by Mokhtar Ahmad, this book describes the development of Malaysia's multi-racial society. Its essay discusses the question of change and modernization in the post-1970 Malaysia, focusing in particular on policies and programs related to Dato' Seri Dr. Mahathir Mohamad became Prime Minister since 1981.
